However, this restriction does not apply to the subscription made under existing regular premium allocation instruction. There is no impact on existing notional unit holdings (if any) in the Investment Choices. There are no restrictions on redemptions or switching out of the Investment Choices.

If you have selected any of the Investment Choices under your insurance policy and if for any reason you wish to change to other investment choice(s), you may switch your investment choice(s) to other available investment choice(s) provided by your policy. Currently, no switching charge and bid-offer spread apply to the investment choices.
